By signing this Hire Agreement, You/Your club are entering into a legal contract with us and confirming that you accept the following:

1. You will pay the full amount of the Balance Due as stated on this Hire Agreement 3 weeks prior to use.

- 2. All of The Equipment is in the Condition as stated on this Hire Agreement at the Start of the Period of Hire.
- 3. If loss or damage occurs to any of The Equipment during the hire period, you agree to pay the full cost of replacement or
- repair of any lost or damaged items within 14 days of the End of the Period of Hire, if the deposit does not cover the costs. 4. We reserve the right to keep the Deposit if any of the Terms & Conditions of this Hire Agreement are broken.
- We reserve the right to keep the Deposit if any of the Terms & Conditions of this Hire Agreement are broken.
 You agree that all persons using the equipment as stated in this hire agreement are ASA members and as such are covered
- by your ASA insurance.

If someone injures themselves whilst using the blocks, we must be informed, and a copy of the accident book / record provided, by signing this agreement 'You agree to provide us with copies of any paperwork in the event that there is an injury resulting in the use of the equipment as stated in the hire agreement'.

7. The blocks will be installed and removed by a BLSC member unless otherwise agreed in advance and must not be removed from Medway Park Leisure Centre

8. The Strobe and cabling must not be removed from the Centre without BLSC permission and only used as per the operating instructions.

9. Where equipment used by a repetitive hirer has incurred damage/loss at their event(s) then BLSC reserve the right to refuse hire.
